

# Affordable On-Water Powerboat Training Courses Now Offered in Milwaukee & Lake Geneva, Wisconsin; South Haven, Michigan

MILWAUKEE, April 8, 2024 – If you have always wanted to see what boating is like, or you're a boat operator with a desire to grow your powerboat-handling skills or give yourself a boost of confidence behind the helm, now is your chance. On-water training provider Boat Safe Great Lakes, Carefree Boat Club, Gull Lake Marine, and the nonprofit BoatUS Foundation for

Boating Safety and Clean Water have teamed up to offer a series of at-the-helm boating courses in Milwaukee and Lake Geneva, Wisconsin, and South Haven, Michigan.

The three-hour on-water courses are affordably priced at \$199 and held aboard 21- to 26-foot single engine powerboats under the watchful eye of a U.S. Coast Guard-licensed instructor. Class size is limited to a maximum of four students per vessel, ensuring everyone gets sufficient time at the helm. Courses follow a National Safe Boating Council modular curriculum and are held Mondays through Thursdays.

Courses follow a sequential learning process that allows you to take the one you need, such as Introduction to Powerboating for beginners, or build upon your skills by continuing with Precision Docking & Boat Handling, Open-Water Boat Handling or A dvanced Maneuvers.

The minimum age to participate is 16 years old, and there is a two-person minimum per boat for the classes to take place. Sign up at <a href="mailto:BoatUS.org/On-Water">BoatUS.org/On-Water</a>



## **Tackling The Tackle Box Essentials**

The fishing's always good in Wisconsin.

Before you pick a spot and head out, equip your tackle box so you're ready with the right bobbers, bait and more. We've got your guide right here.

#### THE TACKLE BOX

Your tackle box doesn't need to be fancy — a small plastic box with a few compartments to keep your hooks, lures and other items organized is just what you need, especially if you're new to fishing.

As your love for fishing grows, your tackle box likely will grow, too! You can find modular boxes that allow you to change the size and shape of the compartments. Or try a tackle box backpack to make your trek to the water easier.

#### MUST-HAVES IN THE BOX

**Baits and lures:** Use these to attract the fish. **Bobbers or floaters:** Keep your line easy to see.

Sinkers: Hold your bait underwater at the proper depth.

**Snap swivels:** Make it easy to change lures and prevent your line from tangling.

**Extra hooks:** There are all kinds and sizes of hooks for catching various types of fish.

Extra fishing line: In case your line breaks.

Pocket knife: To cut the line after attaching a hook, swivel or lure.

**Needle nose pliers:** These help to remove the hook from a fish's mouth.

**Measuring tape:** You can be sure you're within the length limits for any fish you'd like to keep and check if you've caught a new personal best.

First aid kit: Have bandages and antibiotic ointment on hand, just in case.





#### LEARN MORE

You don't need to go far from home for a great fishing spot with plenty of options to shore fish around the state. Learn more about fishing in Wisconsin, such as license information, how to get started, season dates, where to fish and even how you can do it for free. Scan the QR code or check dnr.wi.gov/topic/fishing.

#### **FOR YOU**

**Fishing rod:** For kids, choose a children's rod and reel combination. For adults, a spinning rod and reel is a good choice.

Fishing license: Anglers ages 16 and up need a fishing license in Wisconsin.

**Fishing regulations:** Know the rules for the waterbody where you're fishing.

**Sunscreen:** Guard your skin from the sun, including rays reflected off the water.

Sunglasses: Protect your eyes.

**Snacks:** Don't forget to pack your "snackle box" — you'd hate to cut a trip short because of an empty stomach. Favorite fishing snacks include jerky, nuts, pretzels and dried fruit. And don't forget the water!

## WIS publishes new fishing regulations for the 2024 - 2025 season

MADISON, Wis. – The Wisconsin DNR announced that the 2024 – 2025 Guide To Wisconsin's Fishing Regulations is now available online. These regulations, which include changes to walleye/sauger bag limits on inland waters and new registration rules for small tournaments, went into effect on April 1, 2024.

Now is the perfect time for anglers to review the season dates, any special regulations and the daily bag and size limits for their favorite fishing spots around the state. All license requirements apply.

All residents and non-residents over 16 must have a 2024 – 2025 general fishing license to fish in Wisconsin. Annual resident licenses cost \$20 each, or purchase a spousal license for \$31 so you and your spouse can fish together. All fishing licenses and stamps can be purchased online via Go Wild, at a registered sales location or at DNR Service Centers.

You can find these general fishing regulations as well as the

<u>trout fishing regulations</u> online and at locations where licenses are sold.

#### What's New In 2024 - 2025?

Several <u>new regulations and changes</u> to <u>bag limits</u> have been implemented this year. These changes include:

- A new <u>small tournament</u> registration requirement.
- Statewide daily bag limit of three walleye/sauger per day on all inland waters.
- Walleye bag limits for the Great Lakes (including Green Bay) and Wisconsin-Iowa, Wisconsin-Minnesota and Wisconsin-Michigan boundary waters will remain unchanged, as will limits on any water with a bag limit currently lower than three.
- A person may harvest walleye from two different lakes or rivers with a three-fish daily bag limit as long as they don't exceed the fivefish total daily bag limit.

- A daily bag limit of 10 panfish in Lake Mendota in Dane County.
- Changing the musky minimum length limit to 50 inches on the Wisconsin River from the Lake DuBay Dam upstream to the first dam in Merrill.
- Creating an <u>urban fishing pond</u> in the Village of Suamico in Brown County.

New bag and length limits have also been enacted for specific waterbodies in Brown, Chippewa, Dane, Dunn, Eau Claire, Iowa, Iron, Lincoln, Manitowoc, Marathon, Marquette, Oconto, Pierce, Polk, Portage, Price, Rusk, Sauk, Sawyer, St. Croix, Taylor, Vilas, Walworth, Waukesha and Waushara counties. Multiple design firms have expressed that the Army Corps has been taking 4 to 5 months to approve of permitting on similar projects. If the permitting agencies are able to approve of project in a timely manner, the hope is for construction to be completed over 30 days and completed before the end of summer. *The launch will be closed while construction is active.*

## Club Ongoing Fishing Contest Rules - 2024

- 1. All fish entered must have been caught in Lake Michigan or its connecting waters and must be registered by the angler who caught the fish. Species, weight and date caught must be verified by a witness and weighed on an official, state certified scale. While at the scale, the registrant will fill out and the witness will sign the Club's official entry form. The original copy will be deposited in the writing desk by the scale at the McKinley Marina Cleaning Station, and the carbonless copy will be kept by the member. Please keep this copy as it is your proof of catch. Altered forms will not be accepted. Fish entered in sanctioned contests (see #10) will be allowed when the member furnishes a copy of the entry form. This form must be signed by the official weighing the fish. It is the member's responsibility to get his or her copy to the GLSF contest chairperson or have it placed in the collection box at McKinley Marina within 48 hours of making the catch. All final decisions are subject to approval by the Board of Directors.
- 2. Prior to the opening of the Cleaning station at McKinley Marina, the "Official Weigh-In Station, you will need to use the Temporary Rules published in the box! After the Cleaning station opens, all fish will be weighed on the certified scale at the McKinley Marina Cleaning Station and all forms must be turned in within 48 hours if catching the fish.
- 3. If a fish is being weighed at a sanctioned contest according to rule #10, the weigh-in form and contest verification must be turned in within 48 hours of the catch. For simplification, fish registered at a GLSF Fish In can be registered in the Ongoing Contest by filling out the additional Ongoing Form available at the Fish In weigh-in table, at the time of the weigh-in.
- 4. Awards will be given according to weight. In the event of a tie, the award will be given to the entrant with the earliest registration date.
- 5. The contest will officially run from April 1st through October 31.
- 6. Minimum Size limits for Individual Prizes and Fisherman of the Year

#### **April 1, 2024 – Temporary Instructions!**

Ongoing Fishing Contest! Due to the reconstruction of the McKinley Fish Cleaning Station, please follow these TEMPORARY instructions. Weigh the fish you want to enter on a digital scale that you must provide. With the scale weight showing, take a picture of the scale and the fish. Text that picture, along with your name and address, phone, date and time caught, fish weight, species, and category of entry, adult, kid or Captain's Catch to Jay Mathwick at 1-414-702-5078! Questions can be referred to Jay. We hope to be back to "normal" sometime around July, when the Marina renovations are completed!

- 7. Awards will be given to the first, second, and third place for the adult and junior divisions. The junior division is for member's minor Awards will be given to the first, second, and third place for the adult and junior divisions. The junior division is for member's minor children, not grand-children, 17 years of age and younger. Persons 18 years and older must compete in the adult division. *No one will be eligible for more than one award in each category.* Awards will consist of money for Adults and trophies for Juniors.
- 8. The "Fisherperson of the Year" award of \$50 will be given to the person who registers the highest combined weight of the five-different species and minimum weights above, of salmon and trout. These fish can be accumulated throughout the course of the contest, for a single person, regardless of where they were caught.
- 9. The "Grand Slam" award of \$50 will be given to the fisherperson who registers the heaviest weight of all five species that are caught and registered all on a single fishing trip and registered at the same time. There is no minimum weight requirement for this category.
- 10. The "Captain's Catch Award" of \$50 Dollars will be given to the captain who registers the highest total using the heaviest of each of the five species, registered as Captain's Catch.
  - One captain per boat will be allowed to register. The person who will register as the -Captain" should be determined at the beginning of the contest and remain so for the entire season.
  - To register for this award, place the name of the person who caught the fish on the "witness to catch" line and indicate in the proper box.
  - This registration does not prevent a member from using their personal catch for their own personal awards. A separate registration form should be used for this.
  - · Charter Captains while fishing with charters are ineligible for this award.
- 11. Although the prize is money for the Big Fish of the Month Category, Parents can ask for an alternative prize if they are concerned with scholarship eligibility!
- 12. An Adult monthly award will be given for the "Fish of the Month." The Award of will be given for the largest of the species registered during the month assigned.

- 13. Sanctioned contests are tournaments held by other clubs or organizations and are open to the general public and take place on Lake Michigan and its connecting waters.
- 14. A fish will be considered a "Club Record Fish" if it exceeds the weight of the existing fish and was officially registered in the 'Club Fishing contest under all contest rules. The fish must have been weighed at an official weigh-in station or at a sanctioned contest, and a complete registration form, along with good picture of the fish in the hands of the fisherperson is provided to the contest chairman for publication in the 'Tightline." All final decisions are subject to approval by the Board of Directors..

#### 2024 Fish-In Rules

There are always some members who are unaware of our Summer Fish-in rules and dates. I would like the opportunity to explain our rules for the fish-ins and set forth some additional information for our members new or old. As you review the rules below please keep in mind this is a fun competition for friends and family time. During the summer as a club we do have tournaments, and this is not a fishing tournament. The Fish-ins were created to be fun for all ages from young children, teenagers, good friends, and family members.

#### The rules are as follows:

- 1. Wisconsin Lake Michigan DNR fishing rules apply.
- 2. A maximum of nine rods and lines cannot be exceeded regardless of people fishing.
- 3. Each boat is allowed to keep up to their legal limit. Fish can be released but must be let go immediately after the fish is landed.
- 4. You may start fishing at 5:00am for the first and last dates and 4:00am for the middle to dates.
- 5. Fishing must stop at 11:30am for all dates. You need to be at the weigh-in by 12:00pm located at The Sailing Center. (Keep in mind when traveling to The Sailing Center, that they, and Milwaukee Parks, have other activities that will be going on during the Season which might cause you a delay).
- 6. You can only weigh in up to 10 fish (ONLY 4 Lake Trout can be weighed in). Weigh-in is based on weight only and is accumulative throughout the four events. During the weigh-in the captain or crewmate must specify fish species to the chairperson conducting the weight verification.
- 7. The best three out of four Fish-In results are counted for each boat and the low score is thrown out. For the year end banquet awards the top ten captains will be awarded a prize for the final score of the fish-ins. These will be determined similar to the Southwest Series challenge. Below is an example:
  - The captain with the largest weight will receive a point value as follows per fish-in:
    - 1st place = 100 points 2nd place = 99 points 3rd place = 98 points
    - For each fish-in each captain has an opportunity to earn points just by weighing in.
  - If there is too be a tie breaker in point the system, the one with the larger weight of three fish-ins would break the tie breaker.
- 8. In case of lightning, or Small Craft Advisories being posted, the Fish In will be cancelled using the website, Facebook and usually a phone call to everyone registered to fish. Cancelled Fish Ins are not rescheduled. In case of a cancelled Fish In, all of the completed Fish Ins are used for scoring, instead of the best 3 out of 4 as listed in Rule #7 above.
- 9. At the Banquet there will be prizes awarded to the captains for the top ten boats. Trophies for youth (under 16) catch for first through third place will be awarded
- 10. All boats must launch out of the Milwaukee harbor (McKinley, South Shore, the River Launch or Bender Park).

#### **Kayak Specific Rules**

- 1. A kayak team shall consist of up to 3 persons and 3 kayaks
- 2. All persons from a kayak fishing team shall launch from the same port but are not required to start at the same time.
- 3. Teams should be established prior to the start of fishing time. Substitutions may be made in the event of a no show. This should be done as soon as possible and no later than one hour after start time. (This will be done on the honor system). Persons on a kayak fishing team once launched are NOT required to fish in the same location.
- 4. Kayak fishing teams shall also follow standard GLSF-Milwaukee Fish-in Rules.




# Milwaukee Boat Launching Facilities Updates







## Diverse Habitats Help Salmon Weather Unpredictable Climate Changes





The researchers looked at threatened spring-run Chinook salmon in tributaries of the Sacramento River. They found that restored sites that produce lots of fish may be especially vulnerable to changes such as drought. Such sites should be coupled with other varying sites that support the salmon population in diverse ways.

"The fish need all the different opportunities," said Flora Cordoleani, a NOAA Fisheries and University of California Santa Cruz researcher who led the research published this week in Ecosphere. "Fish with one life history that favors certain habitat are not going to save the population in the long term. We need diverse habitats to support diverse life histories that help provide resilience."

Life history refers to salmon traits such as their juvenile migration timing, growth rates, and food preferences. For instance, some juvenile salmon migrate to the ocean in their first year, while others may spend the year growing in freshwater first. That timing may benefit them in some years, but leave them more vulnerable in others, such as during drought.

Spring Chinook salmon were once found across the state and formed the backbone of California's commercial salmon fishery. They are now greatly diminished and survive in only a few key watersheds with worsening trends in numbers. State and federal biologists last fall collected a few remaining spring-run Chinook salmon to begin a captive broodstock that will safeguard the genetic heritage of the species.

#### **Habitat Mix Benefits Fish**

Fish benefit most when they have access to a mosaic of interconnecting habitat from streamside vegetation to open floodplains, the research found. Young salmon may grow rapidly when wet years inundate floodplains and produce plentiful food, "but that happens pretty rarely," Cordoleani said. "The key is for the fish to have access to all those habitats, so if something happens to one of them, the fish don't all disappear."

The new research goes beyond earlier studies showing that later-migrating fish had better survival rates. It shows how that played out on the landscape of three creeks that feed the Sacramento River, one of the biggest salmon-producing rivers on the West Coast.

Cordoleani and her team examined Butte Creek, the focus of extensive restoration that produced a large increase in fish numbers that had access to the floodplain. They examined salmon otoliths – small ear bones – that record clues about each fish's life history. They found few later-migrating fish, which made the fish there more vulnerable to sharp declines during drought years that may become more common with climate change.

Two other nearby streams, Mill and Deer Creek, offered different conditions and hosted more fish that migrated later as yearlings (juveniles oversummering in freshwater). While they did not see the big increases in fish abundance that Butte Creek did, their salmon better survived droughts. Combining the three sites that complement each other increases the resilience of the Central Valley spring run stock complex—the term for all the individual populations combined.

"The sum of the parts is much greater, because they are doing different things and supporting the fish in different ways," said Rachel Johnson, the senior author of the research and scientist at NOAA Fisheries' Southwest Fisheries Science Center. "Some of those qualities may turn out to be more or less important as the climate changes."

But relying on these three creeks is not enough. "Spring-run Chinook are already playing the climate stock market with only a few stocks in their portfolio," Johnson said. They were once found in every major watershed. She said a lesson of the research is that more habitat options help fish survive a volatile climate by providing more opportunities to survive and thrive.

Providing that array of options requires restoring diverse habitat areas that complement each other at the landscape scale and returning salmon to historical habitats that had long vanished. Cordoleani and her team hope that this research encourages restoration planners to implement projects that create a mosaic of different habitats across watersheds that support diverse fish survival strategies. These actions will also balance each other to help stabilize numbers in the long term. all over the country with teams who have been dedicated to building a sustainable lake trout fishery.
